CCRESA Council Meetings

The councils listed below have met since our last meeting on March 17. I have listed the major topics that were discussed for your information.

Facilities Council Meeting (March 29):

- The meeting was sponsored by Automated Logic.
- The Council discussed district issues/concerns, including the proposed meeting schedule for 2023-24 and potential meeting sponsors for next year.

EC Council Meeting (April 19):

- The meeting was sponsored by Stages Learning.
- Elizabeth Yelverton from NCASA provided a legislative update to the Council, focusing on legislation that impacts EC.
- The Council discussed district issues/concerns, including the proposed meeting schedule for 2023-24 and potential meeting sponsors for next year.

C&I/Tech Councils Joint Meeting (April 25):

Central Carolina Principal Preparation Program (CCP3)

Cohort 3 of CCP3 has been finalized. There are 15 students in the cohort. Classes will begin the fall of 2023.

Coaches for the CCP3 graduates will be trained in Cognitive Coaching beginning this summer. The training will last for 8 days total on the following dates: August 17-18, September 21-22, October 2-3, and November 6-7. The training will take place at the CCRESA offices.
